#### 1. CALL TO ORDER

There being a quorum present, the Chair called the meeting to order at 11:36 a.m.

# 3. APPROVAL OF MINUTES

Mr. Mooney indicated that the minutes of the GRP Review Committee Meeting held on August 19, 2019, were before the Committee for consideration. Motion was made by Mr. Kerry Masson, seconded by Mr. Joe Sherwin, and unanimously carried to approve four (4) to zero (0). Mr. Jackie Chance arrived late and was not present for this vote.

## 4. UPDATES REGARDING GRP DIVISION

#### a. Compliance and Customer Service Update:

Ms. Felkai presented the GRP Monthly Operations Report. She noted that the report included water usage data for the month of August. Ms. Felkai stated that pumpage for August, 2019 was up eight percent (8%) compared to pumpage from August, 2018. Ms. Felkai stated due to year end, there were no financials included in the report; they will be included in next months report.

#### b. Operations and Maintenance Update:

Mr. Sarich provided an operations update. Mr. Sarich stated the plant was running between 15-16 MGD until the September 13, 2019 transmission line break at Research and Technology Drive in The Woodlands. Currently there are seven (7) receiving facilities not receiving surface water. The leak was located and the GRP is currently waiting on the contractor to provide a quote for the scope of work needed. The quote was delayed due to the flooding, but we should be receiving it by the end of the day.

The parties involved in the previous transmission line break were notified and representatives from their companies were given the opportunity to examine the pipe onsite. The broken section of pipe is currently being housed in the GRP warehouse and will be examined by all parties involved.

Mr. Sarich stated a GAC change out of two basins was just completed. The plant is currently running on generator power due to a power outage and the generators came on and are working as they should be.

#### c. Financial Update:

Mr. Smith gave the GRP Division's Financial Update. Mr. Smith stated financials for August 2019 are not available due to year end. The August, 2019 financial numbers will be reported next month with the September, 2019 financial numbers. Mr. Smith added that the GRP General Fund balance, as of August 31, 2019, was \$1,067,960.78, representing approximately .69 months of budgeted operating funds. The balance in the GRP Debt Service Fund, as of August 31, 2019 was, \$21,441,619.77. On October 1, 2019 the Bond Interest/Principal Payment is due in the amount of \$24,289,063.78.
