We at SJRA have been closely monitoring updates and recommendations regarding the COVID-19 virus from the Centers for Disease Control and Prevention (CDC), the Environmental Protection Agency (EPA), and the Texas Commission on Environmental Quality (TCEQ). The water provided by SJRA, as always, is safe and meets, or in many areas exceeds, stringent state and federal standards.

According to the CDC, EPA, and World Health Organization (WHO), the COVID-19 virus has not been detected in drinking-water supplies.
