### Notice of Groundwater Reduction Plan Fiscal Year 2024 Rates for Participants Effective September 1, 2023

June 3, 2023

Dear Participants,

On 5/22/2023, the GRP Review Committee voted to recommend adoption of a proposed GRP Fiscal Year 2024 Operating Budget. The approved Budget does not require any rate increases or amendments to the GRP's Rate Order for Participants. The motion passed with 4 votes in favor, and 2 absent.

Effective September 1, 2023, the Pumpage Fee and Import Fee will remain at the current rate of \$2.99/1,000 gallons, and the Surface Water Fee will remain at the current rate of \$3.41/1,000 gallons. These fees generate the revenues necessary to pay for the operation and maintenance of the GRP facilities and to fund debt service. SJRA strives to effectively manage the costs of operation and maintenance of the GRP facilities so that the lowest responsible fees are adopted under the Rate Order.
