# 50 Years of Devoted Service to The Woodlands



The story of the SJRA Woodlands Division began in 1975, one year after George P. Mitchell founded The Woodlands Township as an “all-encompassing, totally integrated community where residents could live, work, learn and play among a natural forested and preserved environment.” From the beginning, water infrastructure was central to that vision. As development progressed, the original Municipal Utility District (MUD) quickly realized it needed help managing water and wastewater operations. That’s when the SJRA was approached to step in and assist—forming the Woodlands Division to serve as the wholesale provider for the region’s MUDs.

Today, SJRA serves 11 MUDs under the retail oversight of the Woodlands Water Agency (WWA) and an independently operated MUD, partnerships that ensure both effective management and quality service for residents.

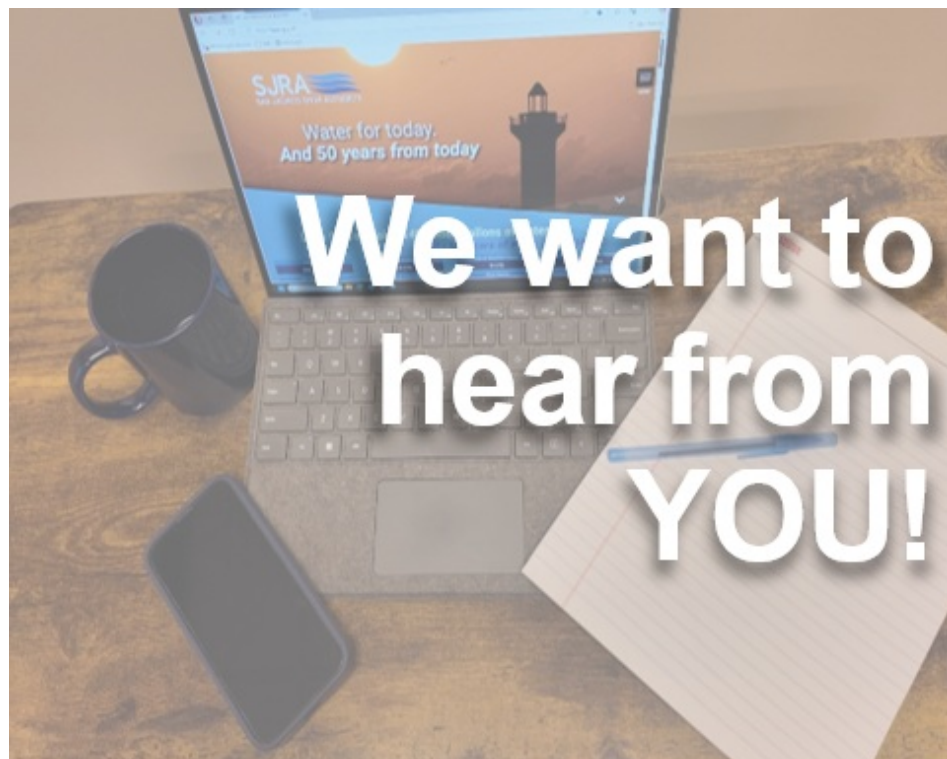

**SJRA does not have taxing authority, nor does it receive funds from the Texas Legislature.** SJRA is funded solely through contracts with its wholesale customers to provide water supply and wastewater treatment. SJRA's mission is to develop, conserve, and protect the water resources of the San Jacinto River basin. Covering all or part of seven counties, the organization's jurisdiction includes the entire San Jacinto River watershed, excluding Harris County. The SJRA is one of two dozen river authorities in the State of Texas, and like other river authorities, its primary purpose is to implement long-term, regional projects related to water supply and wastewater treatment.
