# SJRA Partners with Montgomery County Commissioners on Weather Awareness

This month, SJRA gave presentations to Montgomery County Commissioner Precincts 1, 3, and 4 on various weather awareness resources. This partnership assists county officials during storm season by teaching them about SJRA's [Know Your Watershed](#) (KYW) and Harris County Flood Control District's [Flood Warning System](#) (FWS).

KYW is an interactive mapping tool that allows users to enter their address and find out which watershed they are located in. This information can help users know how the water flows downstream in their area. FWS takes data from rain gages across the area to show real-time rain accumulation as well as other useful data. This can help users see how much rain their area is receiving during a weather event. Thank you to our commissioners for caring for our county and promoting weather awareness.

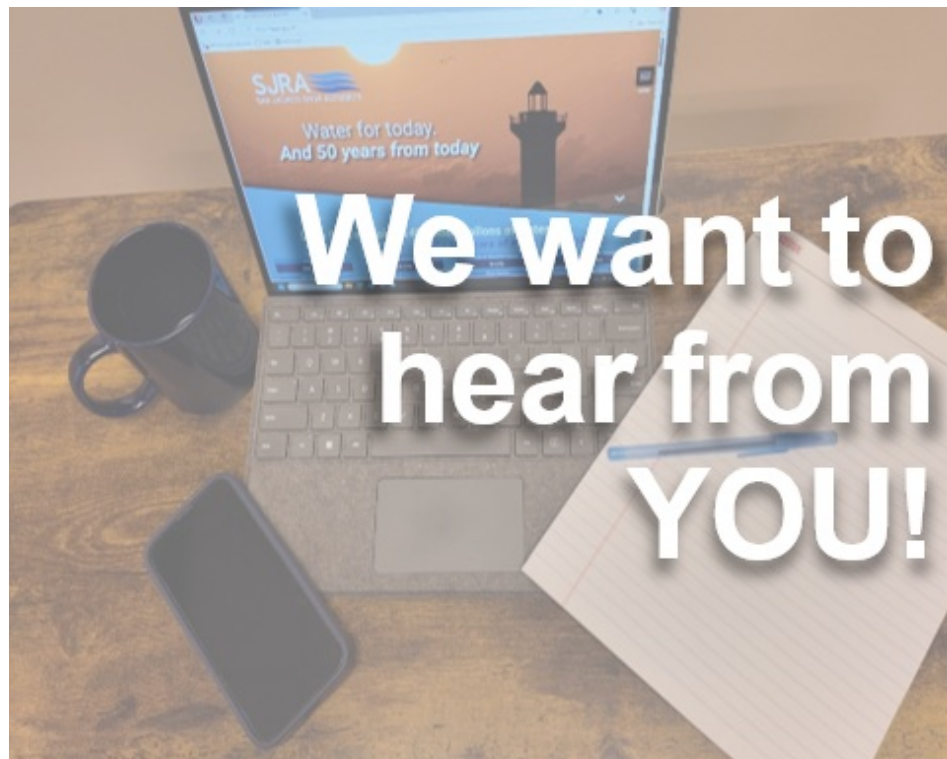

**SJRA does not have taxing authority, nor does it receive funds from the Texas Legislature.** SJRA is funded solely through contracts with its wholesale customers to provide water supply and wastewater treatment. SJRA's mission is to develop, conserve, and protect the water resources of the San Jacinto River basin. Covering all or part of seven counties, the organization's jurisdiction includes the entire San Jacinto River watershed, excluding Harris County. The SJRA is one of two dozen river authorities in the State of Texas, and like other river authorities, its primary purpose is to implement long-term, regional projects related to water supply and wastewater treatment.
